

This visit reflects DBKL's ongoing efforts to engage stakeholders in transforming Kuala Lumpur into a world-class city by 2040.






The success of this event marks an important step in fostering collaboration among stakeholders in heritage conservation, ensuring Melaka's cultural treasures remain protected for years to come.

## PAC TO HOLD PUBLIC HEARING ON SOARING HEALTHCARE COSTS, INSURANCE HIKES

In an unprecedented move, the Public Accounts Committee (PAC) will conduct a public hearing to address the rising costs of health insurance, takaful premiums and private hospital charges, as well as their impact on public healthcare.

"Through this public hearing, all perspectives will be openly considered and incorporated into the PAC report before it is presented in Parliament," the committee stated.

The PAC acknowledged growing public concern over the unchecked increase in private hospital fees and insurance premiums, as well as their strain on the public healthcare system.

"While we welcome the interim measures taken by the government and Bank Negara Malaysia to cap insurance premium hikes, a long-term solution must be explored," the committee emphasised.

To that end, the PAC aims to support the government in drafting a "Private Healthcare Reform" plan through comprehensive discussions with all stakeholders, ensuring public input is taken into account.

Following the public hearing, PAC said it would conduct closed-door proceedings under Rule 85 of the House of Representatives Standing Orders, summoning key stakeholders, including relevant ministries, departments, and government agencies, to provide testimony.

#### **Summary**

"Therefore, PAC invites the public, including (but not limited to): complainants against insurance companies and private hospitals, insurance policyholders, consumer association representatives, insurance agents, insurance company representatives, private hospital management representatives, specialist doctors, private hospital staff representatives, pharmaceutical company representatives, NGOs, academics and healthcare service experts to attend the hearings," it added.

The first public hearing session will take place in Penang at the AC Marriott Hotel, Bukit Jambul on Feb 14 from 9am-12pm. The second will be held in Kuala Lumpur at the banquet hall, main block, Parliament building on Feb 21 from 9am-12pm.

### PAC TO HOLD PUBLIC HEARING ON SOARING HEALTHCARE COSTS, **INSURANCE HIKES**

#### Zero tolerance

Previously, Prime Minister Anwar Ibrahim said the government would not tolerate unjustified increases in health insurance premiums.

"If I am not convinced that the increase is reasonable, I will not support or allow it. This is our principle. Any increase in insurance premiums must be backed by valid reasons.

"For instance, one of the most unreasonable factors is the rate itself. There needs to be a standard, as seen in many countries," he added.

Yesterday, Finance Minister II Amir Hamzah Azizan said the continuous rise in medical inflation has led to an increase in the claims rate for medical and health insurance and takaful.

He was reported as stating that Bank Negara has taken several interim measures to curb the impact of rising premiums, which took effect on Jan 15.

## A winning combination of investment appeal, smart urban planning, and government initiatives



Malaysia's real estate market is experiencing unprecedented growth, with property transactions exceeding MYR217.46 billion in early 2024, surpassing initial targets, according to New Straits Times. Meanwhile, foreign direct investment (FDI) in the sector has surged, with USD1.98 billion invested in the first five months of the year—a 70 percent increase compared to 2023.

This surge is fuelled by a strong focus on affordable housing, infrastructure expansion, and sustainable urban development, positioning Malaysia as a key property investment hub in ASEAN.

#### Affordable housing: A game-changer in Malaysia's real estate growth

Business Today Malaysia stated that Malaysia has taken the lead in affordable housing development in the region, with government-backed initiatives such as PR1MA, Residensi Wilayah, and Rumah Selangorku enabling more Malaysians to own homes. Unlike previous low-cost housing projects, these new developments emphasise liveability, green spaces, and quality community planning.

"One of the primary drivers behind this growth is the Malaysian government's strong commitment to affordable housing," Dr. Nor Atiah states. "However, what sets Malaysia apart from other ASEAN countries is its increasing focus on ensuring that affordability does not compromise liveability."

"Gone are the days when low-cost housing meant poorly designed, dense, and uninspiring spaces. Today, more projects incorporate green spaces, public parks, and community-friendly infrastructure, making affordability synonymous with quality living."

#### Infrastructure development fuels demand in key urban areas

Another key factor behind Malaysia's thriving real estate market is its rapid expansion of public transport networks and expressways, making suburban areas more accessible and attractive to homebuyers and investors. The MRT, LRT, and major highways have helped drive demand for transit-oriented developments (TODs), reported the Bangkok Post.

"The expansion of the MRT, LRT, and major expressways has significantly increased accessibility, making suburban areas more attractive for homeowners and investors," Dr. Nor Atiah explains. "Transit-oriented developments (TODs) are thriving, proving that well-connected, walkable, green urban centres are the future."

"When cities are designed around public transit, they must also consider pedestrian-friendly environments, shaded walkways, green buffers, and public plazas that enhance mobility without depending entirely on cars," Dr. Nor Atiah adds.

#### Sustainability and nature-based solutions take centre stage

As climate change and urban resilience become pressing global issues, Malaysia is leading the way in sustainable real estate development. More projects now integrate biophilic design, green roofs, and floodresilient landscaping to enhance property value while reducing environmental impact.

"Another exciting shift in the property market is the rising demand for nature-inspired developments," Dr. Nor Atiah points out.

"Today's buyers and investors are more conscious of their living environment, preferring sustainable developments, biophilic design, and climate-responsive planning."

This shift reflects a growing awareness of urban heat islands, rising temperatures, unpredictable weather patterns, and worsening floods that are pushing developers to embed climate-conscious planning into their projects.

"We are facing the impacts of climate change—and our built environment must be part of the solution."

"Recognising the urgent need to embrace resilience and sustainable urban planning, the Institute of Landscape Architects Malaysia (ILAM) has been actively championing Nature-Based Solutions (NBS) as a fundamental approach to all developments," Dr. Nor Atiah highlights.

The Sun explained that ILAM has been actively promoting NBS to integrate ecological systems into real estate projects. These strategies include urban forests, flood-resilient landscapes, and biodiversity corridors that regulate temperatures and improve stormwater management.

#### PHARMACISTS SOCIETY BACKS CALL FOR MOROTARIUM ON MEDICINE PRICE DISPLAY

The Malaysian Pharmacists Society says issues with the fee cap under the Private Healthcare Facilities and Services Act 1998 should be resolved first.

PETALING JAYA:

The Malaysian Pharmacists Society (MPS) has joined the calls to the government to delay the implementation of mandatory price displays at private healthcare facilities.

Its president, Amrahi Buang, said the society was aligned with the Malaysian Medical Association (MMA) in calling for a moratorium on the policy until issues with the fee cap under the Private Healthcare Facilities and Services Act 1998 are resolved.

In a statement today, Amrahi said the longstanding fee cap, under Schedule 7 of the Act, has not been revised in over two decades, and its resolution must be prioritised before additional regulatory burdens are imposed.

He also said the government should extend the same moratorium independent community pharmacies. which face significant implementation and digitalisation costs.

"Unlike large pharmacy chains. independent pharmacies may struggle to absorb these costs, potentially affecting their sustainability and ability to serve patients effectively," he said.

Last week, the MMA called for the government to delay the implementation of mandatory price displays until key issues affecting private general practitioners are resolved.

Its remarks came despite the health that ministry maintaining private healthcare facilities must display medicine prices starting this year under the Price Control and Anti-Profiteering Act 2011.

The move has largely been opposed by MMA and the Federation of Private Medical Practitioners' Associations. Malaysia.

Amrahi said the government should consider introducing incentives to encourage compliance with the proposed implementation of mandatory price displays.

He said this approach acknowledges the effort involved while encouraging adherence to the new policy.

"Recognising the financial and administrative burden of compliance, MPS proposes that tax relief or other incentives be provided to healthcare professionals and pharmacies that successfully implement price transparency measures," he said.

He also said mandatory price displays should not be limited to healthcare professionals but should extend to wholesalers and manufacturers as well.

"A holistic approach ensures that transparency is achieved at all levels of the supply chain, preventing undue burden on pharmacies and private healthcare providers," he said

## THIRD-PARTY ADMINISTRATOR PROBLEM STRAINING CLINICS FINANCIALLY, SAYS MMA

#### PETALING JAYA:

The Malaysian Medical Association (MMA) said today there is an urgent need to resolve problems related to third-party administrators (TPAs) as they are "putting a severe strain" on general practitioners' clinics.

While welcoming the government's initiative to review private clinic consultation fees, MMA president Dr Kalwinder Singh Khaira said it was equally important to address challenges related to the role of TPAs, which impacted a significant number of urban patients.



"A critical issue that must also be addressed is the role of TPAs, as 65% of urban patients receive healthcare benefits through these corporate arrangements.

"Many GPs are tied to TPA contracts that impose high administrative fees and fix low consultation rates. Together with delayed payments, this puts a strain on the financial viability of GP clinics," he said in a statement.

Kalwinder said the financial burden on clinics had been compounded by stagnant consultation fees and rising operational costs.

"It is important to note that the current RM10-RM35 consultation fee range was originally proposed by MMA in 1992 before being incorporated into Schedule 7 of the Private Healthcare Facilities and Services Act 1998 in 2006.

"However, there has been no adjustment of consultation fees at all since 1992, despite every other product and service having seen multiple increments over this period," he said.

Kalwinder said private clinics were struggling to stay afloat due to the increasing cost of staff salaries, rentals, utilities and equipment, in addition to the increased costs associated with various regulations imposed over the years.

"The stagnant consultation fees and high operational costs have also led to many private clinics closing down over the past few years," he said.

Kalwinder said the call for a fee review was not about imposing a sudden price hike, but ensuring a fair and sustainable adjustment that reflected the reality of operating costs while maintaining affordability for patients.

"Strengthening the private GP sector as the first point of care will also help reduce overall healthcare costs by improving patient referrals and reducing unnecessary hospital visits," he said.

"In 2015, the health ministry acknowledged that GP consultation fees should be aligned with this range, yet it was never implemented due to non-technical reasons," he said.

It was reported yesterday that the health ministry was reviewing consultation fees for private general practitioners, which has remained unchanged for three decades.

In a written parliamentary reply, health minister Dzulkefly Ahmad said his ministry was collaborating with the statistics department to conduct simulations and determine a suitable price range.

"The ministry is in the process of reviewing consultation fees for private general practitioners, as these rates have not been revised since 2006," he said, adding the review would also consider the impact of any fee adjustment on the consumer price index

#### **MOTORCYCLIST HIGHWAY SAFETY A PRESSING CONCERN**

**PETALING JAYA:** Highway safety remains a pressing concern in Malaysia, particularly for motorcyclists, who account for 70 out of every 100 road fatalities annually.

Universiti Teknologi Malaysia Research Institute for Sustainable Environment director Prof Ts Dr Muhammad Zaly Shah Muhammad Hussein told theSun that between 2019 and 2023, there were 829 motorcycle crashes on three major highways, all with dedicated motorcycle lanes namely the Federal Highway, Kesas Expressway (Shah Alam Expressway) and the Guthrie Corridor Expressway.

"Road traffic crashes remain the leading cause of accident deaths in Malaysia, claiming over 6,500 lives annually.

Existing safety measures such as speed cameras and rumble strips have significantly reduced crashes. However, enforcement inconsistencies and road design limitations continue to contribute to motorcycle-related fatalities," said Muhammad Zaly, who is also Chartered Institute of Logistics and Transport Malaysia president.

He was referring to a road crash on Feb 18 where a 29-year-old nurse Nurul Ilham Nordin lost her life on the Kajang-Silk Highway.

She crashed her motorcycle into a lorry that was parked on the emergency lane, and subsequently was ran over by two other vehicles.

Muhammad Zaly said under Rule 53(1) of the Road Traffic Rules 1959, emergency lanes are strictly reserved for genuine emergencies such as breakdowns or accidents.

#### MOTORCYCLIST HIGHWAY SAFETY A PRESSING CONCERN

He said Malaysia's Road Safety Plan (2022-2030) aims to reduce road fatalities by half through infrastructure improvements and stronger enforcement.

"One key initiative is the expansion of dedicated motorcycle lanes on state and federal roads to separate motorcycles from larger vehicles, minimising the risks of air drift and collisions. However, maintenance and enforcement challenges remain a concern," he said.

To further enhance road safety, the Malaysian Highway Authority has announced an expansion of restrictions on heavy vehicles entering selected Klang Valley highways during peak hours, effective Feb 19 this year.

Heavy vehicles will be banned from these highways on weekdays between 6.30am and 9.30am and 4.30pm and 7.30pm to reduce congestion and improve safety.

Exemptions will be granted for emergency and enforcement services, cleaning and waste disposal, and highway maintenance.

Muhammad Zaly suggested extending these restrictions to all major city highways, particularly those with high motorcycle traffic, to further enhance road safety.

Meanwhile, Universiti Putra Malaysia Head of the Road Safety Research Centre assoc prof Dr Law Teik Hua said poor visibility, especially at night or in bad weather, further increases the dangers for motorcyclists.

"Staying in main lanes is generally safer if motorcyclists maintain safe speeds, avoid blind spots, and use proper signalling. ,,

Law emphasised that strict enforcement measures are necessary to address these risks, including the use of automated cameras and increased patrols to penalise illegal parking and non-emergency use.

Motorcyclists face multiple dangers highways, including speed disparities with larger vehicles, lane splitting, poor visibility, and road hazards such as potholes and oil spills.

"To mitigate these risks, it is crucial to wear helmets, reflective jackets, and protective gear, as well as avoid vehicle blind spots, use headlights during the day, maintain a safe following distance, and undergo advanced rider training programmes."

He said while motorcycles are banned from some expressways, such as at the PLUS highway, enforcement remains weak.

"Stricter measures such as mandatory safety gear checks, dedicated motorcycle lanes, and speed harmonisation are needed to ensure the safety of all road users," he said.

Law recommended expanding dedicated motorcycle lanes, citing Brazil's "blue lane" model, which has resulted in a 40% reduction in motorcycle fatalities.

He also suggested additional measures such as installing barriers to prevent unauthorised use of emergency lanes, introducing AI surveillance to detect and penalise illegal parking, and launching public education campaigns to raise awareness about risks of reckless riding, and stopping on highways.

Due to their speed and size mismatches with other vehicles, motorcycles face inherent risks on expressways.

Law emphasised that emergency lanes should remain strictly for emergencies and not be used as alternative routes for motorcycles.
